### OB3 Gas Pipeline Project to be Completed in March 2024

Nigeria's Minister of State Petroleum Resources (Gas), Ekperikpe Ekpo (the "Minister") announced, at the opening session of the seventh edition of the Nigerian International Energy Summit, that the Obrikom, Obiafo and Oben ("OB3") gas pipeline project will be completed by March 2024.

According to the Minister, the OB3 gas pipeline project serves as a crucial link to the Ajaokuta-Kaduna-Kano gas pipeline, forming an essential part of Nigeria's gas infrastructure. The OB3 gas pipeline project is a one hundred and twenty-seven kilometres and forty-eight inches (127km, 48-inch) gas pipeline, and one of the most substantial gas transmission pipelines in Nigeria and across Africa in terms of pipe size.

## Federal Government Targets 1268MW Boost from Eight (8) New Power Plants

The Federal Government of Nigeria ("FG") is making plans for a significant increase in national power generation by developing eight (8) new power plants. These projects are expected to be constructed through public-private partnerships and are projected to add a combined capacity of one thousand, two hundred and sixty-eight megawatts (1,268MW) to the national grid.

It is noteworthy that four (4) out of the eight (8) power plants have already been awarded to concessionaires while the remaining are expected to be awarded soon.
