#### Lagos State Government Signs Electricity Bill 2024 into Law

On Tuesday, December 3rd, 2024, the Governor of Lagos State, Mr. Babajide Sanwo-olu, signed the Lagos State Electricity Bill 2024 into law, as the "Lagos State Electricity Law 2024" (the "Law") paving a way for an overhaul of the State's energy sector.

This is in line with the provisions of the Electricity Act 2023 and the Fifth Alteration to the Constitution of the Federal Republic of Nigeria, which empower states to establish their electricity markets and regulate the generation, transmission, and distribution of electricity within the state.

#### Aba Power Station Prepares to Commission a Twenty Megawatts (20MW) Line in Owerrenta, Abia State.

The Aba Power Station, also known as the Geometric Power Plant, is set to commission a new twenty megawatts (20MW) line linked to the Owerrenta Industrial Zone on the outskirts of Aba in Abia State.

Mr. Cliff Eneh, a leading electricity consultant, and former senior manager with the defunct National Electric Power Authority ("NEPA") now Power Holding Company of Nigeria ("PHCN") in an interview with journalists on the new development stated that the commissioning activities have commenced ahead of availability of the electricity line in January 2025.

According to Mr. Eneh, factories in the Owerrenta area of Abia state will receive a minimum of twenty-four (24) hours power supply daily upon commission of the electricity line. Similarly, electricity produced will be able to power the industrial machines with large capacities thereby increasing industrialization in Owerrenta and neighbouring communities.

#### Chappal Energies Nigeria Limited Concludes One Billion, Two Hundred Million Dollars (\$1,200,000,000) Acquisition of Equinor Nigeria Energy Company Limited

Chappal Energies Nigeria Limited ("Chappal Energies"), an ingenious energy company in Nigeria, has announced the successful completion of the acquisition of Equinor Nigeria Energy Company Limited ("Equinor") (the "Acquisition"). This marks an end to Equinor's over thirty (30) years experience in energy operations in Nigeria.

The Acquisition grants Chappal Energies a 53.85% percent ownership stake in Oil Mining Lease ("OML") 128 and a unitised (20.21%) percent interest in the Agbami oil field operated by Chevron. In addition to the acquisition, Chappal Energies will assume ownership of OML 129 by reason of the acquisition.
